**NOTIFICATION**

In continuation to this Department's Notification No. 1026-FS/Sectt/Food/4P-17/16 dated 28.03.2018, approval of the Food & Supplies Department is hereby accorded towards payment of Additional Transportation Charges for transportation of paddy from Purchase Centres to tagged Rice Mills for the procurement operation by the State Government of its own through the Centralise Procurement Centres (CPCs) and its designated agencies during the Kharif Marketing Season 2017-18 as per the following table:-

	Distance from Purchase Centres to the tagged Rice Mills	Rate in Rs.
1	For distance up to 25 kms	18.38/qtl.
2	For distance beyond 25 kms and up to 50 kms	50 paisa /km/qtl.
3	For distance beyond 50 kms and up to 100 kms.	20 paisa/kms/qtl.

The Department also accords approval towards additional transportation charges for subsequent transportation of resultant CMR from mills to designated godowns from 0 KM onwards at a flat rate of Rs. 18.38 / quintal for KMS 2017-18.

The concerned Block Food Inspector of the Block and the Block Extension Officer tagged to the Rice Mills will jointly certify the exact distance between the Purchase Centres of the Cooperative Societies and the Rice Mills whereas the District Controllers Food & Supplies and the Sub-Divisional Controllers Food & Supplies shall certify the exact distance between the Centralised Procurement Centres and the Rice Mills and the Rice Mills to the designated godowns in both the cases for onward processing of claim for additional transport charges by Rice Millers.

This order issues with the approval of the Finance Department in terms of their U. O. No. Group A-II/2018-2019/0041 dated 10.10.2018.


